**MUNICIPAL ORDINANCE No. 019**  
Series of 2018

**AN ORDINANCE CREATING THE POSITION SOCIAL WELFARE OFFICER II - SALARY GRADE 15, DEFINING ITS FUNCTIONS AND FOR OTHER PURPOSES**

**WHEREAS**, under the Local Government Code of 1991 grants local government units (LGUs) the power to create offices and positions, thus: "*Section 76. Organization Structure and Staffing Pattern. Every local government unit shall design and implement its own organizational structure and staffing pattern taking into consideration its service requirements and financial capability, subject to the minimum standards and guidelines prescribed by the Civil Service Commission.*"

**WHEREAS**, Section 9 of CSC Memorandum Circular No. 19, s. 1992 expressly authorizes LGUs to create offices, thus: "*Section 9. Other Offices and positions in the organizational structure and staffing pattern not provided under Sections 3 and 4 of these guidelines may be created by local government units: Provided, That they are the priority needs as identified by the local chief executive, the sanggunian and/or the local development councils concerned consistent with Section 17 of the Code ; Provided, further, that the mandatory positions shall have been created, and provided finally, that the budgetary limitations under Sec. 325 of the Local Government Code have been complied.*"

**WHEREAS**, the Local Chief Executive requested the creation of position **SOCIAL WELFARE OFFICER II - SALARY GRADE 15**, under the **Municipal Social Welfare Office**, with the following qualifications:

Education:	Bachelor's Degree in Social Work
Experience:	1 year of relevant experience
Training:	4 hours of relevant training
Eligibility:	RA 1080 (Social Work)

**BE IT ENACTED BY THE SANGGUNIANG BAYAN OF SANTO DOMINGO, ILOCOS SUR IN A REGULAR SESSION ASSEMBLED**

**Section 1. Creation of Position** – There shall be created position **SOCIAL WELFARE OFFICER II - SALARY GRADE 15**, of **Sto. Domingo, Ilocos Sur**.

**Section 2. Functions**– The **SOCIAL WELFARE OFFICER II**, shall have the functions, as follows:

- Assist in planning in the delivery of social services and programs of the unit;
- Conduct interviews, home visits, counseling, case management and jail; visit when necessary;
- Prepares social case study;
- Prepares/submits project proposals, accomplishment reports and other related reports;

**Section 3. Effectivity** – This ordinance shall take effect immediately upon approval.
