**MUNICIPAL ORDINANCE No. 021**  
**Series of 2018**

**AN ORDINANCE REGULATING THE SALE OF LIQUOR AND ALCOHOLIC BEVERAGES FROM TEN O’CLOCK IN THE EVENING (10:00 PM) TO FIVE O’CLOCK IN THE MORNING (5:00 AM) WITHIN THE TERRITORIAL JURISDICTION OF SANTO DOMINGO, ILOCOS SUR, AND PROVIDING PENALTIES FOR VIOLATION THEREOF**

**WHEREAS**, Section 16 of Republic Act No. 7160 otherwise known as the “Local Government Cod of 1991” provides that, “every local government unit shall exercise the powers expressly granted, those necessarily implied there from, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdiction, local government units shall ensure and support, among other things, x x promote health and safety, x x improve public morals, x x maintain peace and order, and preserve the comfort and convenient of their inhabitants;

**WHEREAS**, Section 458 paragraph (a), sub-paragraph (1) (v) of the same Code provides that,” the SANGGUNIANG BAYAN, being the Legislative Body, shall enact ordinances intended to prevent, suppress and impose penalties for habitual drunkenness in public places x x and such other activities inimical to the welfare and morals of the inhabitants of the Municipality;

**BE IT ENACTED BY THE SANGGUNIANG BAYAN OF SANTO DOMINGO, ILOCOS SUR IN A REGULAR SESSION ASSEMBLED**

**ARTICLE 1. TITLE** – This ordinance shall be known as “**AN ORDINANCE REGULATING THE SALE OF LIQUOR AND ALCOHOLIC BEVERAGES FROM TEN O’CLOCK IN THE EVENING (10:00 PM) TO FIVE O’CLOCK IN THE MORNING (5:00 AM) WITHIN THE TERRITORIAL JURISDICTION OF SANTO DOMINGO, ILOCOS SUR, AND PROVIDING PENALTIES FOR VIOLATION THEREOF.**

**ARTICLE 2. DECLARATION OF POLICY-** the Municipal Government of Santo Domingo, Ilocos Sur shall regulate the sale of liquor and alcoholic beverages to any retail outlets and sari-sari stores within the territorial jurisdiction of Santo Domingo, Ilocos Sur.

**ARTICLE 3. REGULATORY PROVISIONS** – all retail outlets and sari-sari stores selling liquor and alcoholic beverages is strictly prohibited from **TEN O’CLOCK IN THE EVENING (10:00 PM) TO FIVE O’CLOCK IN THE MORNING (5:00 AM)**.

**ARTICLE 4. ADMINISTRATIVE PROVISIONS** –

**Section 1.** The office of the Mayor, through the assistance of the Sto. Domingo PNP as well as the Barangay Officials of this municipality are hereby authorized to implement this ordinance.

**Section 2.** The office of the Mayor, through the assistance of the Sto. Domingo PNP as well as the Barangay Officials shall institute appropriate and widest information dissemination to all concerned.

**ARTICLE 5. - PENAL PROVISION** - all retail outlets and sari-sari stores who will be caught selling liquor and alcoholic beverages shall be fined, with the following:

- First Offense – a fine of Php 500.00**
- Second Offense – a fine of Php 1,000.00**
- Third Offense – a fine of Php 2,000.00 and revocation of business permit.**

**ARTICLE 6. – SEPARABILITY CLAUSE** – In the event that any provision of this ordinance is declared invalid, the other provisions not affected thereby shall remain in full force and effect.

**ARTICLE 7. – REPEALING CLAUSE** – All local laws, rules and regulations which are inconsistent with this ordinance are hereby repealed or modified accordingly.

**ARTICLE 8. – EFFECTIVITY CLAUSE** – this ordinance shall take effect fifteen (15) days upon approval and posting in three (3) conspicuous places.
