**AN ORDINANCE APPROPRIATING THE TOTAL AMOUNT OF ONE MILLION NINE HUNDRED TWENTY THREE THOUSAND THREE HUNDRED TWENTY FIVE PESOS (Php 1,923,325.00) AS THE SUPPLEMENTAL BUDGET NO. 4 OF SANTO DOMINGO, ILOCOS SUR FOR FISCAL YEAR 2018**

**WHEREAS**, the OIC Municipal Treasurer, Ms. CLAUDIA B. JARAMILLO and the ICO Municipal Accountant, Ms. MARJORIE F. TADENA, jointly certifies the existence of an amount of **ONE MILLION NINE HUNDRED TWENTY THREE THOUSAND THREE HUNDRED TWENTY FIVE PESOS (Php 1,923,325.00)** as **TOTAL AVAILABLE RESOURCES FOR APPROPRIATION**, sourced from **TAX REVENUE** and **REVERSION OF APPROPRIATIONS**.

**WHEREAS**, the items indicated for Supplemental Appropriation are the real felt-need of the Municipality for an efficient and effective delivery of basic services.
