**AN ORDINANCE PROVIDING GUIDELINES FOR THE UTILIZATION OF AGRICULTURAL MACHINERIES AND FARM EQUIPMENTS OWNED BY THE MUNICIPALITY OF SANTO DOMINGO, ILOCOS SUR AND ISSUED TO BARANGAYS AND TO FARMERS ASSOCIATION**

**WHEREAS**, it is the vision of the Municipal Government to have an empowered and productive citizens.

**WHEREAS**, In pursuit of said vision, it is the mission of the Municipal Government to accelerate Agricultural and Fishery productivity and rural tourism.

**WHEREAS**, In accord with the said vision/mission, the Municipal Government of Santo Domingo, Ilocos Sur procured, and will continue to provide agricultural machineries and farm equipments so that were issued by way of entering into a Memorandum of Agreement (MOA) to deserving and accredited farmers associations of Santo Domingo, Ilocos Sur.

**NOW, THEREFORE**, in view of the foregoing premises, on motion duly made and seconded, this august Body, in session duly assembled, resolved to enact:

**BE IT ENACTED BY THE SANGGUNIANG BAYAN IN A SESSION DULY ASSEMBLED**

**Section 1. TITLE-** This Ordinance shall be known as “**PROPER UTILIZATION OF AGRICULTURAL MACHINERIES AND FARM EQUIPMENTS ISSUED TO BARANGAYS AND TO FARMERS ASSOCIATION**”

**Section 2. DECLARATION OF POLICY-** It is hereby declared a policy of the Municipality to promote the development and adoption of modern, appropriate and cost-effective and environmentally-safe agricultural and fisheries machinery and equipment to enhance farm productivity and efficiency in order to achieve food security and safety and increase farmers’ income;

**Section 3. QUALIFICATION OF BENEFICIARIES -** No Farmers Association shall be qualified as beneficiaries if they are not duly accredited by the Municipality, through the Sangguniang Bayan. The “**ONE BARANGAY, ONE FARMERS ASSOCIATION POLICY**” is continuously adopted. A Barangay may be considered as beneficiary.

**Section 4. IMPLEMENTATION-** In no case that an Agricultural machineries and Farm Equipment be issued to Farmers Association or organization if not supported by Memorandum of Agreement (MOA) indicating thereto the terms and conditions.

**Section 5. MAINTENANCE** --The beneficiaries shall shoulder the repair and maintenance. In the event of double violation made by the beneficiary, the Municipality will recall the issued agricultural machinery and Farm Equipment.

**Section 6. RATES OF SERVICE FEE-** The Service Fee of the Agricultural Machineries and Farm Equipment is dependent on the prevailing rates being offered by other service providers.

**Section 7. MODE OF PAYMENT** – all fees and remittances shall be paid at the Office of the Municipal Treasurer on weekly basis and will be considered as income of the Municipality to be accrued under the General Fund.

**Section 8. NET INCOME SHARING** – the sharing of Net Income shall be as follows: 40% for the Municipal Government and 60% for the Barangay/Association.

**Section 9. SEPARABILITY CLAUSE** - In the event that any section, paragraph, sentence, clause or word of this ordinance is declared invalid for any reason other provisions thereof should not be affected thereby.

**Section 10. REPEALING CLAUSE** - All ordinances as well as pertinent rules and regulations thereof which are inconsistent with the provisions of this Ordinance are hereby repealed or amended accordingly.

**Section 11. EFFECTIVITY** - This Ordinance shall take effect immediately upon its approval.
