**RESOLUTION AUTHORIZING THE HONORABLE AMADO T. TADENA, MUNICIPAL MAYOR OF SANTO DOMINGO, ILOCOS SUR TO ENTER INTO MEMORANDUM OF AGREEMENT (MOA) WITH KAMP PAGKAKAISA VOLUNTEERS (CHARITY) INC. REPRESENTED BY ENGR. REYNALDO S. SAN AGUSTIN FOR THE IMPLEMENTATION OF THE 10 DAY THERAPEUTIC SUMMER CAMP FOR CHILDREN WITH SPECIAL NEEDS IN THE MUNICIPALITY**

**WHEREAS**, the Municipality of Santo Domingo, Ilocos Sur is upholding the government mission of providing avenues for Children with Special Needs (Children with Down Syndrome, Children with Autism, Mentally Challenged and Physically Disabled) and those children in difficult circumstances and exposed to all forms of deprivation.

**WHEREAS**, the Municipality of Santo Domingo, Ilocos Sur represented by **Hon. Mayor AMADO T. TADENA** is extending help to facilitate and sponsor the **10 DAY THERAPEUTIC SUMMER CAMP FOR CHILDREN WITH SPECIAL NEEDS IN THE MUNICIPALITY OF SANTO DOMINGO, ILOCOS SUR**.

**WHEREAS**, the Camp Site recommended is at North Central School, Sto. Domingo, Ilocos Sur, with an estimated budget of ₱ 1.2M for 12 days camp including transportation back and forth to transport 250 campers and volunteers from Metro Manila, expenses for camp preparation and coordination, advance group to prepare the campsite and the 3 day training for 50 local volunteers.

**WHEREAS**, the Municipality of Santo Domingo, Ilocos Sur will help the **KAMP PAGKAKAISA VOLUNTEERS (CHARITY) INC.** to the DEPED authorities for the camp venue, to LGU for support on the logistic needs of the camp like lights around the camp site perimeter, potable waters and provision of rooms with appropriate toilets by the school.

**WHEREAS**, the **KAMP PAGKAKAISA VOLUNTEERS (CHARITY) INC.** is a non government organization (NGO) that organize a 10 day Therapeutic Summer Camp for Children with Special Needs and going to different places in the Philippines since 1979 and still continuing for its 41<sup>st</sup> camp in Ilocos Sur to help educate people about the plight of children with special needs.

**WHEREAS**, the **KAMP PAGKAKAISA VOLUNTEERS (CHARITY) INC.** has the expertise in providing therapeutic summer camping for children with special needs and adult persons with disabilities (PWDs) who are manifesting problems of adjustment, attitudes, social relationship and intellectual limitations affecting their social being.

**WHEREAS**, the **KAMP PAGKAKAISA VOLUNTEERS (CHARITY) INC.** is registered under Securities and Exchange Commission since its inception in 1979 and its updated Mayor's Permit to operate in Antipolo as its new office. And in the process of application for accreditation with the DSWD as an NGO as they transfer to its new office in Antipolo.

**NOW THEREFORE**, in view of the foregoing, on motion of the Committee Chair on Social Services, **HON. CRISTINA JANE G. DE VERA**, unanimously seconded, this august body in a session duly assembled, hereby,
