RESOLUTION FIXING THE DAY, TIME AND PLACE OF THE REGULAR SESSION OF THE SANGGUNIANG BAYAN OF SANTO DOMINGO, ILOCOS SUR

WHEREAS, The Local Government mandates that “ON THE FIRST DAY OF THE SESSION IMMEDIATELY FOLLOWING THE ELECTION OF ITS MEMBERS, THE SANGGUNIAN SHALL, BY RESOLUTION, FIX THE DAY, TIME, AND PLACE OF ITS REGULAR SESSION.

WHEREAS, The Internal Rules of Procedures of the Sangguniang Bayan provides that “The Regular Session of the Sangguniang Bayan shall be once a week to be held at the Municipal Session Hall, unless the August Body agreed by majority vote to be held in some other places, every Monday at nine o’clock in the morning. However, if the day of the regular session falls on a holiday or on a red mark on the calendar, the day of session shall be held on the next working day.”

NOW THEREFORE, premises considered, upon motion of SBM GODOFREDO T. INGAN, seconded by SBM MICHAEL EMILI V. FIGUERAS AND SBM RIZALDY S. ROSARIO, this August Body, in a session duly assembled;

RESOLVED, as it is hereby resolved, to fix the schedule and venue of the Regular Session of the Sangguniang Bayan of Santo Domingo, Ilocos Sur of which it will be every Monday at nine o’ clock in the morning at the Municipal Session Hall. However, if the day of the regular session falls on a holiday or a red mark on the calendar, the day of session shall be held on the next working day.
