TADENA, AS ONE OF THE SIGNATORIES OF ALL WARRANTS DRAWN ON THE MUNICIPAL TREASURY FOR ALL EXPENDITURES AT THE DEVELOPMENT BANK OF THE PHILIPPINES - VIGAN CITY BRANCH APPROPRIATED FOR THE OPERATION OF THE MUNICIPALITY OF SANTO DOMINGO, ILOCOS SUR EXCEPT THE OPERATION OF THE SANGGUNIANG BAYAN OF SAME MUNICIPALITY

WHEREAS, HON. FLORO T. TADENA has assumed the duties and functions of the Municipal Mayor of Santo Domingo, Ilocos Sur effective 01 July 2019 he being the proclaimed winner in the Mayoralty Race of May 13, 2019 election.

WHEREAS, as provided under the Local Government Code of 1991, one of the powers, duties and functions of the Municipal Mayor is to sign all warrants drawn on the Municipal Treasury for the operation of the Municipality, as that it is deemed proper and fitting to authorize **Municipal Mayor Honorable FLORO T. TADENA** to be one of the signatories of all warrants drawn on the Municipal Treasury for all expenditures at the Development Bank of the Philippines – Vigan City Branch appropriated for the operation of the Municipality except the operation of the Sangguniang Bayan for the same is vested with the Municipal Vice Mayor.

NOW THEREFORE, premises considered, on motion of the Committee Chair on Finance and Appropriation **HON. GODOFREDO T. INGAN**, unanimously seconded, this August Body, in a session duly assembled;




