- WHEREAS, as provided under the Local Government Code of 1991, one of the powers, duties and functions of the Municipal Mayor is to sign all warrants drawn on the Municipal Treasury for the operation of the Municipality, as that it is deemed proper and fitting to authorize Municipal Mayor Honorable FLORO T. TADENA to be one of the signatories of all warrants drawn on the Municipal Treasury for all expenditures at the Development Bank of the Philippines Vigan City Branch appropriated for the operation of the Municipality except the operation of the Sangguniang Bayan for the same is vested with the Municipal Vice Mayor.
- NOW THEREFORE, premises considered, on motion of the Committee Chair on Finance and Appropriation HON. GODOFREDO T. INGAN, unanimously seconded, this August Body, in a session duly assembled;
