RESOLUTION ADOPTING AND APPROVING THE MDC RESOLUTION NO. 5, SERIES OF 2019, ENTITLED "RESOLUTION ENDORSING TO THE SANGGUNIANG BAYAN FOR REVIEW AND APPROVAL OF THE LIST OF PROJECTS TO BE FUNDED BY THE 2016 MUNICIPAL SHARE FROM RA 8240 (EXCISE TAX FROM BURLEY AND NATIVE TOBACCO) AS PER LOCAL BUDGET MEMORANDUM NO. 79 DATED JUNE 14, 2019 AMOUNTING TO ONE MILLION SEVEN HUNDRED THIRTY TWO THOUSAND EIGHT HUNDRED FIFTY FOUR PESOS (PHP 1,732,854.00)

- WHEREAS, the Department of Budget and Management issued Local Budget Memorandum No. 79 with the subject, Guidelines on the release and utilization of the shares of Local Government Units from the FY 2016 collections of excise tax on locally manufactured Virginia-type cigarettes under RA 7171, and Burley and Native tobacco excise tax pursuant to RA 8240, as amended by RA 10351, chargeable against the allocations to local government units under FY 2018 General Appropriations Act, Republic Act No. 10964, continuing appropriations;
- WHEREAS, Annex B of LBM No. 79 provide the LGUs share from the CY 2016 collection of Burley and Native Tobacco excise tax under RA No. 8240, as amended; Sto. Domingo, Ilocos Sur One Million Seven Hundred Thirty Two Thousand Eight Hundred Fifty Four Pesos (Php 1,732,854.00)
- WHEREAS, The Municipal Development Council Executive Committee has convened to deliberate the priority programs to be funded from the unreleased Municipal Share under RA 8240 base on the guidelines set under LBM No. 79; to wit;
