WHEREAS, one of the purposes of Republic Act 10121 otherwise known as Philippine Disaster Risk Reduction Management Act of 2010 is to strengthen the capacities of the Local Government Units in mitigating and preparing for, responding to, and recovering from the impact of disasters.

WHEREAS, Disaster Risk Reduction Management is not only the responsibility of the government but it is a duty of all the sectors in the society to come up with a participative disaster resilient community.

WHEREAS, the Municipal Government can engage the participation of the civil society organizations (CSOs), the private/government sector and volunteers in the government's disaster risk reduction program towards complementation of resources and effective delivery of services to the citizenry.

WHEREAS, various distributors of goods and services from the private sector in the municipality are engaged in purified drinking water distribution, canned goods, noodles, ready to eat meals distributor, gasoline, lumber, engineering heavy equipments, disaster equipment/tools, funeral parlors, financial institutions and other necessary services where the LGU can engage their humanitarian services in case of severe calamity.

NOW THEREFORE, premises considered, on motion of the Committee Chair on Peace and Order, **HON. EUGENE R. TADEJA**, unanimously seconded, this August Body in a session duly assembled,

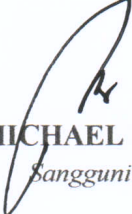
RESOLVED FURTHER, that the Memorandum of Agreement shall be binding for the duration of the term of the elected Municipal Officials.

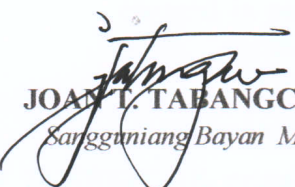

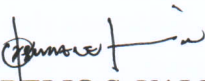

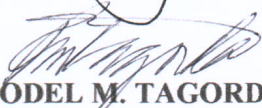
