WHEREAS, this Localized Anti-Criminality Action Plan (LACAP) sets forth the prescribes guidelines and procedures to help address and prevent the incidence of Theft and Robbery that occurred in the Municipality;

WHEREAS, This Localized Anti-Criminality Action Plan (LACAP) recommends the enactment of an Ordinance which will elevate the preventive security measures against theft, robbery and other related crime incidents perpetrated by domestic boarders and visitors, lawless elements or groups that may transpire within the Municipality; and will require every Barangay the proper accounting and identification of boarders, gather vital information, and identify their purpose in staying within the Municipality, provided that the respect for Human Rights must be strictly observed;


