RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. FLORO T. TADENA, TO ENTER INTO MEMORANDUM OF AGREEMENT (MOA) WITH THE NATIONAL FOOD AUTHORITY (NFA) REPRESENTED BY ITS OIC-PROVINCIAL MANAGER LOLITA O. SENEDRIN, CPA, FOR THE IMPLEMENTATION OF RICE SUPPLY PROGRAM

- WHEREAS, the National Food Authority pursuant to Republic Act 11203 is the government agency mandated to maintain an optical level of rice inventory at any given time to be used for emergency situations and to sustain the disaster-relief programs of the government during natural or man-made calamities.
- **WHEREAS**, under the Local Government Code of 1991, Local Government Units are vested with authority to discharge the functions and responsibilities of national agencies and offices devolved to them.
- WHEREAS, Local Government Units (provinces/cities/municipalities) have been tasked with providing basic social service at all times particularly in times of calamities.
- WHEREAS, the Local Government Units in order to provide immediate assistance to their constituents, has requested the NFA to allow them to purchase rice on cash and credit for relief distribution operation/stockpiling/prepositioning as part of their disaster preparedness and other needs of their various projects/programs.
- WHEREAS, the Local Government Units are authorized to set aside five percent (5%) of their Internal Revenue Allotment or any amount from their estimated revenue for unforeseen expenditures arising from the occurrence of calamities, provided that such appropriation shall be used only in the area affected by a disaster or calamity.
- WHEREAS, the Local Government Units are required to set aside an amount equivalent to twenty percent (20%) of the estimated revenue from regular sources as annual lump sum appropriation for Local Disaster Risk Reduction and Management Fund to support disaster risk management activities.
- NOW THEREFORE, premises considered, on motion of the Committee on RULES chaired by HON. LUCIANO F. MANUEL, unanimously seconded, this August Body in a session duly assembled;
- RESOLVED, AS IT IS HEREBY RESOLVED, to authorize the MUNICIPAL MAYOR, HON. FLORO T. TADENA, TO ENTER INTO MEMORANDUM OF AGREEMENT (MOA) WITH THE NATIONAL FOOD AUTHORITY (NFA) REPRESENTED BY ITS OIC-PROVINCIAL MANAGER LOLITA O. SENEDRIN, CPA, FOR THE IMPLEMENTATION OF RICE SUPPLY PROGRAM.
- RESOLVED FURTHER, that copy of this resolution be forwarded to NATIONAL FOOD AUTHORITY OIC-PROVINCIAL MANAGER LOLITA O. SENEDRIN, CPA, and all other concerned agencies for their information and favorable action.
