RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. FLORO T. TADENA, TO ENTER INTO MEMORANDUM OF AGREEMENT (MOA) WITH THE BENITO SOLIVEN ACADEMY REPRESENTED BY ITS PRINCIPAL MS. MARIVIC F. REALIN, FOR THE IMPLEMENTATION OF SENIOR HIGH SCHOOL WORK IMMERSION PROGRAM

- WHEREAS, the Department of Education is primarily government instrumentality mandated to formulate, implement, and coordinate policies, plans, programs and projects in the areas of formal and informal basic education; supervise all elementary and secondary education institutions, including alternative learning systems, both public and private; and provide for the establishment and maintenance of a complete, adequate, and integrated system of basic education relevant to the goals of national development;
- **WHEREAS,** Deped has introduce the K to 12 basic education reform program that includes Senior High School, with the major objective of ensuring that graduates of basic education are ready for employment, entrepreneurship and higher learning.
- WHEREAS, the Senior High School curriculum can be customized at the local levels to take into consideration the needs of local industries and the labor market;
- WHEREAS, Deped believes that for effective delivery of Senior High School instruction, there is a need for school-industry partnerships that will provide the school the necessary expertise and venue for practical, on-the-job, enterprise-based training for Senior High School learners;
- WHEREAS, Deped will start full implementation of Senior High School in School Year 2016 2017.
- WHEREAS, the BENITO SOLIVEN ACADEMY is among those that will offer Senior High School to students in the community to carry out DepEd's objectives for Senior High School as spelled out above.
- WHEREAS, to achieve this objective, the BENITO SOLIVEN ACADEMY needs to enter into a Work Immersion partnership with the Local Government Unit.
- WHEREAS, the Local Government Unit operates in the area where the school is located and has offices, facilities, projects sites, and expertise that can make available to the School for purposes of students work immersions;
- **WHEREAS,** the Local Government Unit considers going into a work immersion partnership with the school as part of its mission to create a positive impact on the community, especially the young people.
- **WHEREAS**, the institutionalization and implementation of the K to 12 program is among the priority programs of the government for promoting inclusive growth.
- WHEREAS, the Local Government Unit is encouraged to fully support the successful implementation of the K to 12 program of the Department of Education as stated in Paragraph 4, Section 2 of the Republic Act 9155 or "Governance of Basic Education Act of 2001".
- **WHEREAS,** the Local Government Unit recognizes the need for a work immersion environment that is safe for the students and teachers, and conducive to learning, and has capability to provide these;
- WHEREAS, the BENITO SOLIVEN ACADEMY and the LOCAL GOVERNMENT UNIT OF SANTO DOMINGO, ILOCOS SUR, undertake to collaborate toward the successful implementation of the SENIOR HIGH SCHOOL in BENITO SOLIVEN ACADEMY, Sto. Domingo, Ilocos Sur, cognizant of the need for special protection of the child and with the best interest of the SENIOR HIGH SCHOOL learners at heart.
