for the

PURCHASE AND INSTALLATION OF CCTV ALONG NATIONAL HIGHWAY AND PUBLIC MARKET INCLUDING PERMITS AND OTHER APPROPRIATE LICENSES

The Municipality of Santo Domingo, Blacos Sur, through the Supplemental Budget No. 01, 2021 (General Fund) intends to apply the sum of Two million eight hundred thousand peace (P 2,800,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for the Purchase and Installation of CCTV along National Highway and Public Market including Permits and Other Appropriate Licenses. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The Municipality of Santo Domingo, Ilocos Sur now invites bids for the Purchase and Installation of CCTV along National Highway and Public Market including Permits and Other Appropriate Lizenses. Completion of the Works is required Thirty (30) Calendar Days. Bidders should have completed, within ten (10) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II: Instruction to Bidders.

Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the implementing Rules and Regulations (RR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

interested bidders may obtain further information from Municipality of Santo Domingo, Ilocos Sur and inspect the Bidding Documents at the address given below from April 28-May 18 2021; 8:00AM - 12:00 AM; 1:00PM - 5:00PM.

A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of Five thousand pesos (P 5,000.00).

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (Philippine Government Electronic Procuring Entity, provided that bidders shall pay the fee for the Bidding Documents not later that the submission of their bids.

The Municipality of Santo Domingo, flocos Sur will hold a Pre-Bid Conference on May 05, 2021 @ 9AM at the Conference Hall, Sto. Domingo, flocos Sur which shall be open to all interested parties.

Bids must be delivered to the address below on or before May 18, 2021 @ 9AM at the Office of the BAC Chairman, Santo Domingo, Ilocos Sur. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITS Clause 19.

Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below, tate bids shall not be accepted.

The Municipality of Santo Domingo, flocos Sur reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
