INVITATION TO BID
for the
**REHABILITATION/CONCRETING OF FARM TO MARKET ROAD
LOCATED AT CALAUTIT, STO. DOMINGO, ILOCOS SUR**

The Municipality of Santo Domingo, Ilocos Sur, through the RA 7171 (2018 Municipal Share) / LBM 83 intends to apply the sum of Four million two thousand nine hundred thousand six hundred twenty three & 75/100 pesos (P 4,209,623.75) being the Approved Budget for the Contract (ABC) to payments under the contract for Rehabilitation/Concreting of Farm to Market Road located at Calautit, Sto. Domingo, Ilocos Sur. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The Municipality of Santo Domingo, Ilocos Sur now invites bids for Rehabilitation/Concreting of Farm to Market Road located at Calautit, Sto. Domingo, Ilocos Sur. Completion of the Works is required Sixty seven (67) Calendar Days. Bidders should have completed, within ten (10) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II: Instruction to Bidders.

Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

Interested bidders may obtain further information from Municipality of Santo Domingo, Ilocos Sur and inspect the Bidding Documents at the address given below from February 16-March 08, 2023; 8:00AM – 12:00 AM; 1:00PM – 5:00PM.

A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of Five thousand pesos (P 5,000.00).

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the fee for the Bidding Documents not later than the submission of their bids.


The Municipality of Santo Domingo, Ilocos Sur will hold a Pre-Bid Conference on February 23, 2023 @ 9AM at the Conference Hall, Sto. Domingo, Ilocos Sur which shall be open to all interested parties.

Bids must be delivered to the address below on or before March 08, 2023 @ 9AM at the Office of the BAC Chairman, Santo Domingo, Ilocos Sur. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The Municipality of Santo Domingo, Ilocos Sur reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
