RESOLUTION ADOPTING AND APPROVING THE LOCAL YOUTH DEVELOPMENT PLAN FOR CY 2020–2022 OF SANTO DOMINGO, ILOCOS SUR

WHEREAS, Section 8 (a) of RA 10742 otherwise known as “SK Reform Act of 2015” states that the Sangguniang Kabataan, in consultation and concurrence of the Katipunan ng Kabataan, and within three months from assumption to office, formulate a three year rolling plan, which shall be known as the Comprehensive Barangay Youth Development Plan (CBYDP) which shall be the basis in the preparation of the Annual Barangay Youth Investment Program (ABYIP). This plan shall be aligned with the Philippine Youth Development Plan and other Local Youth Development Plan in every municipality, city, and province;

WHEREAS, Section 8 (h) of RA 10742 provides that the SK shall partner with the Local Youth Development Council in planning and executing projects and programs of specific advocacies like good governance, climate change adaptation, disaster risk reduction and resiliency, youth employment and livelihood, health and anti-drug abuse, gender sensitivity and sports development;

WHEREAS, Section 3 (h) of RA 10742 provides that Municipal Youth Development Plan as initially drafted by the SK Pederasyon, finalized by the LYDC and approved by the Local Sanggunian. Local Youth Development Plan (LYDP) shall be anchored on the Philippine Youth Development Plan (PYDP) and the local development plans of the local government unit concerned;

WHEREAS, in accordance with DBM-DILG-NYC Joint Memorandum Circular No. 1, Series of 2019, dated January 23, 2019 – Guidelines on the Appropriation Release, Planning, and Budgeting process for the SK Funds.

WHEREAS, on October 17, 2020, the SK Pederasyon of Santo Domingo, Ilocos Sur had drafted the Local Youth Development Plan CY 2020–2022 and it was presented to Local Youth Development Council on February 24, 2021 to finalize the said plan to ensure that the projects and programs are aligned with the Philippine Youth Development Plan CY 2020 – 2022;

NOW THEREFORE, premises considered, on motion of the Committee on Youth and Sports Development chaired by **SK Federated President, Hon. Jelly Ann Rose T. Tindoc**, unanimously seconded, this August Body in a session duly assembled;

RESOLVED, as it is hereby Resolved, adopt and approve the **Local Youth Development Plan CY 2020 – 2022;**
