RESOLUTION AUTHORIZING MR. RUSSELL S. ALCANCIADO, MPDC, IN HIS CAPACITY AS THE DESIGNATED IN-CHARGE OF OFFICE (ICO) OF THE OFFICE OF THE MUNICIPAL TREASURER OF SANTO DOMINGO, ILOCOS SUR, AS ONE OF THE SIGNATORIES OF ALL WARRANTS DRAWN FROM THE MUNICIPAL TREASURY FOR ALL EXPENDITURES APPROPRIATED FOR THE OPERATION OF THE MUNICIPALITY AND REPRESENTATIVE IN ALL TRANSACTIONS TO THE LAND BANK OF THE PHILIPPINES

WHEREAS, MR. RUSSELL S. ALCANCIADO, MPDC, has been designated as the In-Charge of Office (ICO) of the Office of the Municipal Treasurer of Santo Domingo, Ilocos Sur, in lieu of Mrs. Claudia B. Jaramillo whose designation as such has expired;


WHEREAS, the Local Government Code of 1991, provides that the Municipal Treasurer will take custody of, and exercise proper management of the funds of the LGU concerned and to take charge of the disbursement of all and such other funds, the custody of which may be entrusted to him/her by law or other competent authority;


NOW THEREFORE, in view of the foregoing, on motion of the Committee Chair on Finance and Appropriation, Honorable **GODOFREDO T. INGAN**, unanimously seconded, this august Body, in a special session duly assembled, hereby;


RESOLVED, as it is hereby **RESOLVED**, to authorize **MR. RUSSELL S. ALCANCIADO, MPDC**, in his capacity as the designated In-Charge of Office (ICO) of the Office of the Municipal Treasurer of Santo Domingo, Ilocos Sur, as one of the signatories of all warrants drawn from the municipal treasury for all expenditures appropriated for the operation of the municipality and representative in all transactions to the Land Bank of the Philippines






