RESOLUTION REQUESTING ASSISTANCE FROM THE DA – REGIONAL FIELD UNIT 1 FOR THE PROVISION OF RICE PROCESSING CENTER (RPC) FROM THE OFFICE OF THE DIRECTOR, HON. NESTOR D. DOMENDEN, CESO IV, OIC-REGIONAL EXECUTIVE DIRECTOR OF THE DEPARTMENT OF AGRICULTURE

- WHEREAS, the Local Government Unit of Santo Domingo, Ilocos Sur realizes that having control over all aspects of the agriculture industry is the only way to attain its dream of a genuine agricultural development;
- WHEREAS, the LGU has been successful in yielding socio-political and economic gains in its small-scale agricultural production;
- WHEREAS, to improve its productivity and save postharvest losses, the LGU needed to acquire basic production and post-harvest facilities such as RICE PROCESSING CENTER (RPC);
- WHEREAS, the LGU has 2,915 hectares of agricultural land which is more than or equal to the minimum required area land to avail of the assistance package;
- WHEREAS, the LGU has an average rice yield of 5.3 tons per hectare per year;
- WHEREAS, the LGU has 3,634 farmers that will directly benefit under the facility and has access to the services of expert personnel to manage and operate the said facilities;
- WHEREAS, the LGU has an available warehouse/shed located in the Farmers Productivity Center, Parada, Sto. Domingo, Ilocos Sur which can be legally used for the official garage of such facilities especially when not in use;
- WHEREAS, the LGU of Santo Domingo, Ilocos Sur will endorse this Resolution to the Office of the Sangguniang Panlalawigan of Ilocos Sur, through Hon. Efren Rafanan for their appropriate action and recommendation;
- **NOW THEREFORE,** premises considered, on motion of the Committee Chairman on Agriculture, Cooperative, Trade and Industry, HON. JOAN T. TABANGCURA, unanimously seconded, this August Body, in a session duly assembled;
