**Invitation to Bid for**  
**PROCUREMENT/INSTALLATION OF SOLAR-POWERED STREET LIGHTS**  
**IN VARIOUS BARANGAYS OF STO. DOMINGO, ILOCOS SUR**

- 1) The **Municipality of Santo Domingo, Ilocos Sur**, through the **20% Development Fund** intends to apply the sum of **Seven million pesos (₱ 7,000,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for **Procurement/Installation of Solar-powered Street Lights in Various Barangays of Sto. Domingo, Ilocos Sur**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2) The **Municipality of Santo Domingo, Ilocos Sur** now invites bids for **Procurement/Installation of Solar-powered Street Lights in Various Barangays of Sto. Domingo, Ilocos Sur**. Completion of the Works is required **within forty-eight (48) calendar days**. Bidders should have completed, **within ten (10) years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders (ITB).
- 3) Bidding will be conducted through competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the IRR, otherwise known as the "New Government Procurement Act (NGPA)".  
  
Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.
- 4) Interested bidders may obtain further information from the **Municipality of Santo Domingo, Ilocos Sur** and inspect the Bidding Documents at the address given below from **February 13 to March 05, 2026; 8:00AM – 12:00 AM; 1:00PM – 5:00PM**.
- 5) A complete set of Bidding Documents may be acquired by interested bidders on **February 13 to March 05, 2026** from the Office of the BAC Chairman: and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Ten thousand pesos (₱ 10,000.00)**.  
  
It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.
- 6) The **Municipality of Santo Domingo, Ilocos Sur** will hold a Pre-Bid Conference on **February 20, 2026 @ 9AM** at the **Conference Hall, Sto. Domingo, Ilocos Sur** which shall be open to prospective bidders.
- 7) Bids must be duly received by the Bids and Awards Committee (BAC) Secretariat through manual submission at the address indicated below on or before **March 05, 2026 @ 9AM**. Late bids shall not be accepted.
- 8) All Bids must be accompanied by a Bid Security in any of the acceptable forms and in the amount stated in ITB Clause 16.
- 9) Bid opening shall be on **March 05, 2026 @ 9AM** at the **Conference Hall, Sto. Domingo, Ilocos Sur**. Bids will be opened in the presence of the Bidders' representatives who choose to attend the activity.
- 10) *An authorized representative must present an original signed authorization Letter or Special Power-of- Attorney (SPA) along with a valid Government Issued ID and a photocopy of their own ID and the document owner's ID to prove their authority to act someone's behalf and most specifically state the purpose for which the representative is acting.*
- 11) The **Municipality of Santo Domingo, Ilocos Sur** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 70 of R.A. No. 12009, without thereby incurring any liability to the affected bidder or bidders.
