RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR HONORABLE AMADO T. TADENA, TO ENTER INTO A CONTRACT OF LEASE WITH MR. MAXIMO ASUNCION SR., THE EXCLUSIVE PRIVILEGE TO GATHER BANGUS FRY/KAWAGKAWAG AT THE TERRITORIAL SEA WATER OF SANTO DOMINGO, ILOCOS SUR

WHEREAS, There is imperative need to again lease these bangus fry zones through public bidding and the lease to Bangus Fry Zone was awarded to the lone Bidder Mr. Maximo Asuncion Sr.

WHEREAS, Article 87 (vi) of the Rules and Regulation implementing the Local government code of 1991 provides that upon authorization of the Sangguniang Bayan, the Municipal Mayor represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance;

WHEREAS, The Zone 6, which is specifically located north of Sabangan, Sived, after measuring a distance of 760 meters up to the Santo Domingo, Magsingal Boundary which is designated as Bangus Fry Reservation under PD. 704 hence it is off limits to lease holders.


