- WHEREAS, the Local Government Unit of Santo Domingo, Ilocos Sur has expressed its need, goal and objectives, through a letter request addressed to the President of the University of Northern Philippines, and duly endorsed to the College of Engineering.
- WHEREAS, the Local Government Unit of Santo Domingo, Ilocos Sur is the only municipality in the 1st District of Ilocos Sur that has established Municipal Sanitary Landfill Project.
- WHEREAS, the Local Government Unit of Santo Domingo, Ilocos Sur has chosen to seek technical assistance of the University of Northern Philippines, in the supervision of the construction of its Sanitary Landfill project and proper Sanitary Landfill Operation.
- WHEREAS, the President has assigned the College of Engineering to take charge in the desire assistance.
- **WHEREAS**, the University of Northern Philippines through the College of Engineering, is duly-bound to perform extension service and make itself available for the country-side.
- WHEREAS, both the Local Government Unit of Santo Domingo, Ilocos Sur and the University of the Philîppines – College of Engineering, recognize that in resources sharing, cooperation and interdependence, networking and linkages, they could attain their respective goals and objectives.
