WHEREAS, Republic Act No. 7160, otherwise known as the Local Government Code of 1991, states that the functions and responsibilities for the delivery of basic health services and other related facilities have been transferred from the Department of Health to the Local Government Unit.

WHEREAS, the Municipality of Santo Domingo, Ilocos Sur is considered by the Department of Health as one of the municipalities in the Philippines that is in dire need of another Rural Health Physician who will help address the various health problems of an increasing populace.

WHEREAS, the Department of Health, pursuant to its mandate of providing adequate health human resource in all municipalities especially in hard-to-reach areas is recommending to provide a much needed MHO Assisting Physician, by the name of **DR. CRISTINA H. GOROSPE** under the Doctors to the Barrios Program, and the Local Government of Santo Domingo is willing to accept the same.

WHEREAS, **DR. CRISTINA H. GOROSPE**, agrees to serve in the Municipality of Santo Domingo as part of the Doctors to the Barrios Program.




