WHEREAS, the High Value Crops Development Program is one of the priority programs of the Department of Agriculture created to help address food security, poverty alleviation and sustainable growth. It helps to promote the production, processing, marketing and distribution of high value crops. Strategically, HVDCDP envisions the production of safe and healthy food, increased income, create livelihood opportunities to contribute to national agricultural development.

WHEREAS, to achieve its goal, Season Long Training of Trainers' is one of the extension supports being offered. It is a modified season-long program which has been designed for the participants of this course. This aims to enhance the technical capabilities and decision-making skills of the Agricultural Extension Workers (AEWs) being the partners of Agricultural Training Institute (ATI) towards human resource development efforts in the countryside. Graduates from the training course are expected to effectively capacitate the farmers in their own respective areas to help improve their decision making capacity of farming communities and stimulating local innovation for sustainable agriculture.

WHEREAS, the Agricultural Training Institute (ATI) is the extension and training arm of the Department of Agriculture and is mandated to train all agricultural STAKEHOLDERS, especially **Agricultural Extension Workers (AEWs) and farmers and to ensure that research results are communicated through appropriate training and extension activities. Hence, implement the Season Long Training of Trainers on Sustainable Vegetable Production.**

WHEREAS, the Third Party Provincial/Municipal Local Government Unit (P/M LGU) will support and allow the TOT Trainee to participate fully and complete the Season Long Training of Trainers on Sustainable Vegetable Production.


