RESOLUTION REQUESTING THE DENR COMMUNITY ENVIRONMENT AND NATURAL RESOURCES OFFICE (CENRO), THROUGH OIC, CENR OFFICER FRANCISCO C. ARENAS, TO DONATE THE TREES CUT ALONG THE NATIONAL HIGHWAY WITHIN THE TERRITORIAL JURISDICTION OF SANTO DOMINGO, ILOCOS SUR SO THESE COULD BE MADE INTO DESK AND CHAIRS AND OTHER SCHOOL ESSENTIALS FOR PUBLIC SCHOOLS WITHIN SANTO DOMINGO, ILOCOS SUR

WHEREAS, The DPWH applied for permit to cut trees to give way to the improvement/widening of national road coverage of which is the Manila North Road, which includes the National Highway traversing within the territorial jurisdiction of Santo Domingo, Ilocos Sur, the application was granted through SPECIAL TREE CUTTING PERMIT NO. 2019-03, dated May 10, 2019 issued by the DENR Community Environment and Natural Resources, Ilocos Sur.

WHEREAS, in said SPECIAL TREE CUTTING PERMIT, one of the provisions states that: *“The trees cuts and parts thereof shall be turned-over to this Office (CENRO Ilocos Sur Office) for proper disposition based on existing guidelines”*.






RESOLVED FINALLY, to forward copies of this resolution to all concerned offices and agencies for their information, record and appropriate action.
