RESOLUTION ADOPTING AND APPROVING MDC RESOLUTION NO. 01, SERIES OF 2019, ENTITLED "RE-PROGRAMMING THE CONTINUING APPROPRIATION OF THE 20% DEVELOPMENT FUND AMOUNTING TO ONE MILLION EIGHT HUNDRED THIRTY THOUSAND SEVEN HUNDRED SIXTY TWO PESOS AND THIRTY CENTAVOS (Php 1,830,762.30) AND CURRENT APPROPRIATION OF THE 20% DEVELOPMENT FUND 2019 AMOUNTING TO THREE HUNDRED THOUSAND PESOS (Php 300,000.00)

WHEREAS, there are funded projects which were not implemented due to same reasons;

WHEREAS, there is a need to re-program the continuing appropriation funded projects which are not implemented due to the implementation of updated guidelines on the appropriation and utilization of the 20% Annual Development Fund for development projects. Other funds from the 20% Development Fund are the unexpended budgets from the implemented projects. This is to finance the priority projects in order to achieve desirable socio-economic development and environmental outcomes of the municipality;

WHEREAS, a total of One Million Eight Hundred Thirty Thousand Seven Hundred Sixty two Pesos and 30/100 (Php 1,830,762.30) under the 20% Development Fund continuing appropriation and Three Hundred Thousand Pesos (Php 300,000.00) under the 20% Development Fund current appropriation shall be re-programmed for the felt needs of the Municipality, as follows:
