RESOLUTION AUTHORIZING THE MUNICIPAL ADMINISTRATOR, MRS. MA. CORAZON V. TADENA, Ph.D, TO ACT FOR AND IN BEHALF OF THE MUNICIPAL MAYOR IN SIGNING SOME OF THE FINANCIAL DOCUMENTS AND TO SIGN ALL WARRANT DRAWN ON THE MUNICIPAL TREASURY FOR ALL EXPENDITURES APPROPRIATED FOR THE OPERATION OF LGU SANTO DOMINGO, ILOCOS SUR INVOLVING AN AMOUNT NOT EXCEEDING TWO HUNDRED THOUSAND PESOS (Php 200, 000) EXCEPT THOSE FOR THE OPERATION OF THE SANGGUNIANG BAYAN OF SANTO DOMINGO, ILOCOS SUR

WHEREAS, MA. CORAZON V. TADENA, Ph.D. has been appointed by the Municipal Mayor as **MUNICIPAL ADMINISTRATOR I** under Co-terminous status of Santo Domingo, Ilocos Sur, and will perform duties and functions as provided by law and such other functions validly delegated by the Municipal Mayor.


WHEREAS, the Municipal Mayor, Hon. Floro T. Tadena, has delegated to the Municipal Administrator, MRS. MA. CORAZON V. TADENA, PhD, to act for and in his behalf in signing some of the financial documents and all warrant drawn on the municipal treasury for all expenditures appropriated for the operation of LGU Santo Domingo, Ilocos Sur involving an amount not exceeding TWO HUNDRED THOUSAND PESOS (Php 200, 000), in order to accelerate the pace of the work of the local government administration.

NOW THEREFORE, premises considered, on motion of the Chair on Finance and Appropriation, **HON. GODOFREDO T. INGAN**, unanimously seconded, this August Body in a session duly assembled,

RESOLVED as it is by **RESOLVED**, to Authorize the Municipal Administrator, **MRS. MA. CORAZON V. TADENA, PhD**, to act for and in behalf of the municipal mayor in signing some of the financial documents and to sign all warrant drawn on the municipal treasury for all expenditures appropriated for the operation of LGU Santo Domingo, Ilocos Sur involving an amount not exceeding two hundred thousand pesos (Php 200, 000) except those for the operation of the Sangguniang Bayan of Santo Domingo, Ilocos Sur


