WHEREAS, before this August Body is a request for consideration and adoption of the Supplemental Annual Investment Plan No. 2 of Santo Domingo, Ilocos Sur, funded from the ER1-94 OF THE DEPARTMENT OF ENERGY AMOUNTING TO THREE MILLION FOUR HUNDRED FIFTY THOUSAND PESOS (PHP 3,450,000.00), from the 2016 RA 7171 MUNICIPAL SHARE AMOUNTING TO FIFTY-EIGHT MILLION EIGHT HUNDRED EIGHTY-EIGHT THOUSAND SIX HUNDRED TWENTY PESOS (Php 58,888,620.00), and from the 2016 MUNICIPAL SHARE FROM RA 8240 (EXCISE TAX FROM BURLEY AND NATIVE TOBACCO) AMOUNTING TO ONE MILLION SEVEN HUNDRED THIRTY TWO THOUSAND EIGHT HUNDRED FIFTY FOUR PESOS (PHP 1,732,854.00);
