RESOLUTION ADOPTING AND APPROVING THE LOCAL PUBLIC TRANSPORT ROUTE PLAN OF SANTO DOMINGO, ILOCOS SUR

- WHEREAS, the Department of Interior and Local Government (DILG) and Department of Transportation (DOTr) issued JMC Circular No. 001, series of 2017 RE: guidelines on the preparation and issuance of Local ordinances, Orders, rules and regulations concerning the Local Public Transport Route Plan (LPTRP).
- WHEREAS, Executive Order 125-A and Administrative Order 202, Series of 1987, constituting with the National Government Policy, authorize and promote adequate, safe, reliable, efficient and environmental-friendly Public Utility Vehicle (PUVs).
- **WHEREAS,** Section 17 of the LGC further provides that LGUs, shall endeavour to provide adequate, effective and efficient transportation facilities that would provide access and mobility for the people to pursue socio-economic activities as reflected in the CLUP.
- WHEREAS, the DOTr recognizes the subsidiary principle that LGUs are in better position to identify Local Public Transport Services requirements and formulate plans for improving connectivity between and among their urban and rural socio economic activities, in the Province and Regions they are part of.
- WHEREAS, there is a need for the LGU to formulate the Local Public Transport Route Plan (LPTRP) to support the goal of DOTr for making the country's Public Transport System efficient and environmentally friendly by 2020.
- NOW THEREFORE, premises considered, on motion of the Committee Chair on Transportation, HON. EUGENE R. TADEJA, unanimously seconded, this August Body in a special session duly assembled:
- RESOLVE AS IT IS HEREBY RESOLVED, to ADOPT AND APPROVE THE LOCAL PUBLIC TRANSPORT ROUTE PLAN OF SANTO DOMINGO, ILOCOS SUR.
- **RESOLVED FURTHER**, to furnished copies of this Resolution to all offices/agencies concerned for their information, record and appropriate action.
