RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. FLORO T. TADENA, AND THE OIC MUNICIPAL TREASURER MS. CLAUDIA B. JARAMILLO TO ENTER INTO MEMORANDUM OF AGREEMENT (MOA) WITH THE DEVELOPMENT BANK OF THE PHILIPPINES (DBP) FOR PROVIDING FINANCIAL ASSISTANCE IN THE FORM OF SALARY LOAN TO QUALIFIED OFFICERS AND EMPLOYEES OF LOCAL GOVERNMENT UNIT, SANTO DOMINGO ILOCOS SUR

WHEREAS, the Development Bank of the Philippines has launched a salary loan facility (hereinafter referred to as the “Salary Loan Facility”) of providing financial assistance in the form of salary loans to qualified officers and employees of the Local Government Unit – Santo Domingo, Ilocos Sur in accordance with the DBP Consumer Lending for Government Agency.


WHEREAS, in consideration of DBP’s agreement to extend salary loan facility to qualified officers and employees, the Local Government Unit – Santo Domingo, Ilocos Sur has agreed to fulfill certain obligations relative to its accreditation, the eligibility of the borrowers, and the remittance to the DBP of the monthly amortization due, in accordance with the salary Loan Facility.

WHEREFORE, premises considered, on motion of the Committee on RULES chaired by **HON. LUCIANO F. MANUEL**, unanimously seconded, this August Body in a session duly assembled;




