WHEREAS, the ILOCOS SUR COMMUNITY COLLEGE is offering Bachelor of Science in Information Technology (BSIT) as authorized by the Commission on Higher Education (CHED);

WHEREAS, the ILOCOS SUR COMMUNITY COLLEGE (ISCC) has instituted an on-job training program wherein qualified students who are officially enrolled in the BSIT Curriculum will undergo training prior to graduation to be adequately qualified with the actual on-the-job experience to match the academic curricula, which the industry needs and demands to augment their formal training;

WHEREAS, the ILOCOS SUR COMMUNITY COLLEGE (ISCC) proposes that its students be allowed to undergo on-the-job training program at the LOCAL GOVERNMENT UNIT OF STO. DOMINGO, ILOCOS SUR, which proposal was accepted/approved by the latter, subject to the terms and conditions provided for this Agreement (on-the-job training program);


