RESOLUTION AUTHORIZING HON. FLORO T. TADENA, MUNICIPAL MAYOR OF SANTO DOMINGO, ILOCOS SUR TO ENTER INTO MEMORANDUM OF AGREEMENT (MOA) WITH THE MUNICIPALITY OF STA. LUCIA REPRESENTED BY THE HONORABLE MAYOR JOSEPH SIMON B. VALDEZ FOR THE AVAILMENT OF THE SERVICES AND FACILITIES OF THE LATTER'S STO. DOMINGO SANITARY LANDFILL

- WHEREAS, the Municipality of Sto. Sto. Domingo, Ilocos Sur owns and operates a Sanitary Landfill, built and operated in accordance with RA 9003 and RA 6969 and is a DENR-EMB registered final disposal facility for treated hazardous wastes;
- WHEREAS, the LGU of Sta. Lucia, Ilocos Sur desires to avail and make use of the said engineered sanitary landfill of the Municipality of Sto. Domingo, Ilocos Sur.
- WHEREAS, After a review of the submitted MOA, prepared at the instance of the LGU of Sto. Domingo, Ilocos Sur, members of this august body finds its provisions acceptable and ideal in order to provide a dumpsite where garbage, refuse and other waste of our LGU could be discarded or disposed;
- NOW THEREFORE, premises considered, on motion of the Committee Chairman on Natural Resources and Environmental Protection, HON. MICHAEL EMILI V. FIGUERAS, unanimously seconded, this August Body in a regular session duly assembled,
- RESOLVED as it is by RESOLVED, to authorize HON. FLORO T. TADENA, MUNICIPAL MAYOR OF SANTO DOMINGO, ILOCOS SUR TO ENTER INTO MEMORANDUM OF AGREEMENT (MOA) WITH THE MUNICIPALITY OF STA.
