RESOLUTION APPROVING THE PROCUREMENT OF DISASTER EQUIPMENTS TO BE FUNDED BY 2018 LOCAL GOVERNMENT SUPPORT FUND – ASSISTANCE TO MUNICIPALITIES (LGSF-AM) PROGRAM

WHEREAS, as per DILG Memorandum Circular No. 2018-61, dated May 3, 2018 provides the Policy Guidelines and Procedures in the implementation of the FY 2018 Local Government Support Fund – Assistance to Municipalities (LGSF-AM) Program;

WHEREAS, in a letter dated September 3, 2019, from the Bureau of Treasury informed that an amount of Eleven Million and Thirty Five Thousand Pesos (Php 11,035,000.00) was credited to the Municipality to cover cash requirement for the implementation of Priority Programs and projects funded from LGSF – AM, with SARO No. LGRB-19-00011483 dated September 5, 2019;

WHEREAS, the amount of Eleven Million and Thirty Five Thousand Pesos (Php 11,035,000.00) were allocated for the purchase of the following equipments as follows; 1) **procurement of 2 units Pick Up for conversion into a rescue Vehicle with necessary equipment and apparatus** and 2) **procurement of 3 units Multi-purpose vehicle for conversion into rescue vehicle with necessary equipment and apparatus;**


