The Municipality of Santo Domingo, Ilocos Sur, through the 20% Development Fund intends to apply the sum of Two million forty one thousand eight hundred sixty two & 26/100 pesos (P 2,041,862.28) being the Approved Budget for the Contract (ABC) to payments under the contract for the Construction of Multi-purpose Building (Motorpool) located at San Pablo, Sto. Domingo, Ilocos Sur. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The Municipality of Santo Domingo, Ilocos Sur now invites bids for the Construction of Multi-purpose Building (Motorpool) located at San Pablo, Sto. Domingo, Ilocos Sur in the amount of Two million forty one thousand eight hundred sixty two & 28/100 peacs (P 2,041,862.28). Completion of the Works is required Sixty nine (69) Calendar Days. Bidders should have completed, within ten (10) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II: Instruction to Bidders.

Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

Interested bidders may obtain further information from Municipality of Santo Domingo, flocos Sur and Inspect the Bidding Documents at the address given below from February 23-March 15, 2021, 8:00AM – 12:00 AM; 1:00PM – 5:00PM.

Bids must be delivered to the address below on or before March 15, 2021 @ 9AM at the Office of the BAC Chairman, Santo Domingo, flocos Sur. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The Municipality of Santo Domingo, flocos Sur reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
